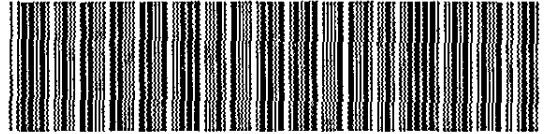

TWO:




