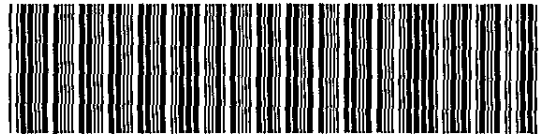

ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

Article I Name

The name of the corporation shall be:
Christian Revival Tabernacle, Inc.

Article II Principal Office

Article III Purpose

1. In accordance therewith, this church entity is organized exclusively for religious purposes, including the making of distributions to organizations that will qualify as tax exempt organizations under section 501 (c) 3 of the Internal Revenue Code, or the corresponding sections of any future federal tax code, and to provide organization, rules and procedures to govern the membership of the church and to:

- (a) To establish and maintain a place of worship.
- (b) To unite a people of like faith in the bonds of brotherly love and fellowship (Heb. 13:1)
- (c) To meet together to truly worship God in Spirit and in truth and to receive spiritual teaching (John 4:24; Eph. 4:11-15)
- (d) To point the lost to the way of life by publishing at home and abroad the true plan of salvation, exhorting believers to be filled with the Spirit of God according to Acts, Chapter 2.
- (e) To provide rules of Christian conduct based upon the Word of God. (Titus 2)
- (f) To assist the body of believers in realizing their full potential for the Lord through discovery and development of their spiritual gifts in a variety of effective and fulfilling ministries (Eph. 4:11-12).
- (g) To do any other lawful acts as provided for by the laws of the State of Florida.

2. Notwithstanding any other provisions of these articles, the church entity shall not carry on any other activities not permitted to be carried on by (a) by a church entity or corporation exempt from Federal Income Tax under section 501 (c) 3 of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a church entity or corporation, contributions, to which are deductible under the Internal Revenue Code section. No part of the activities of this church entity or corporation shall be in violation with the provisions of the Internal Revenue Code for non-profit corporations regarding legislative or political activities.

3. No part of the net earning of this church entity or corporation shall inure to the benefit of, or be distributable to, its members, officers, or other private persons except that the church entity or corporation shall be authorized and empowered to pay reasonable compensation for services rendered as stated further in the by-laws of Christian Revival Tabernacle, Inc.

Article IV Manner of Election

The manner in which the directors are elected or appointed:
The Board of Directors shall be nominated by the pastor and voted upon by the church for alternate terms of up to three years.

Article V No Personal Liability

No director of the corporation shall be personally liable to the corporation for monetary damages for breach of any fiduciary duty as a director, except for any liability which cannot be limited by these Articles under state law.
