

AMENDMENT TO ARTICLES OF INCORPORATION TWIN SPRINGS MISSIONARY BAPTIST CHURCH OF JACKSONVILLE FLORIDA, INC.

This Amendment to Articles of Incorporation of Twin Springs Missionary Baptist Church of Jacksonville Florida, Inc., a Florida corporation, is executed; acknowledged and presented to amen said Articles of Incorporation as

ARTICLE III - SECTION 3

- a) The organization is organized exclusively for charitable, religious, educational, and/or scientific purposes under section 501 © (3) of the Internal Revenue Code of 1954.
- b) Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 © (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the court of common pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
