

Articles of Incorporation In Compliance with Chapter 617, F.S., (Not-for-Profit)

Article I: Name

The name of the corporation shall be:

Village of Biscayne Park Homeowners Committee, Inc.

Article II: Principal Office

The principal place of business and mailing address of this corporation shall be:

735 Northeast 113th Street Biscayne Park, FL 33161

Article III: Purpose

The purpose for which the corporation is organized is:

- 1. To unite property owners in the Village of Biscayne Park (hereinafter referred to as "Village") area to create a community spirit and harmonious neighbor relations through social activities, newsletter and such other means intended to accomplish this purpose.
- 2. To promote community activities and interest in the Village area.
- 3. To take actions to maintain and improve the safety, welfare and land values in the Village area.
- 4. To welcome new residents to the community and seek their participation in activities of the Village and to inform residents, recent and old, on matters of interest to them through the V.B.P.H.C. newsletters and web site.
- 5. To engage in civic and educational activities which the V.B.P.H.C. and members determines to be necessary to protect the health, safety, welfare and land values of the Village.
- 6. To follow the expenditures of money, and other actions, of the city, county and state governments which have an impact or effect upon the Village, or its members, and to determine the interest and position of the V.B.P.H.C. members on such matters and to make their position known to the appropriate government bodies or officials through the appointed representatives/officers of the V.B.P.H.C. and to keep the members apprised of such matters.
- 7. To take actions to seek to preserve the cleanliness and safety of the roads, medians and public areas inside the Village.

Article IV: Manner of Election

To be elected, and to continue to hold office as a Director, a person must meet all of the following requirements:

2. Sign and submit a Declaration of Interest and Ability to Serve, in the form adopted by the Board of Directors, at the time of nominations or, in any event, prior to being voted on by general membership.
