ARTICLE ONE - NAME

ARTICLE TWO - DURATION

The corporation shall have a perpetual existence

ARTICLE THREE - PURPOSE

The purpose of this corporation is:

#### ARTICLE FIVE

##### OFFICES AND TRUSTEES

The affairs of the Corporation are to be managed by a Board of Trustees. Each trustee shall be appointed to a committee that shall have its own specific function as to education and/or social activities. The Bylaws of the Corporation are to be made, altered or rescinded by the Directors of the Corporation in accordance with Laws of the State.

#### ARTICLE EIGHT

##### AMENDMENTS TO ARTICLES

These Articles of Incorporation may be amended by the act of the Members of the Corporation. Such amendments may be proposed and adopted in the manner provided in the Bylaws of the Corporation.

## ARTICLE NINE

### REGISTERED OFFICE AND AGENT

Upon accepting this designation agrees to comply with the provisions of Section 48.091, Florida Statutes as Amended from time to time, with respect to keeping an office open for service of process.

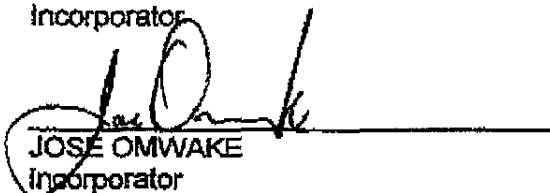
