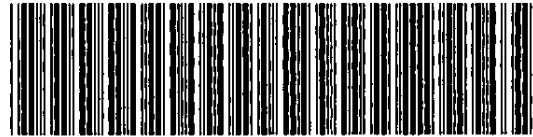

ARTICLE XIV: Organization and Distributions

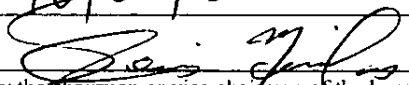
