**Articles of Incorporation
(Restated)
of
Neighborhoods United for a Better Alachua, Inc.**

Article I

The name of the corporation shall be Neighborhoods United for a Better Alachua, Inc..
The principal address is 15319 NW 140th Street, Alachua, Florida.

Article II

The period of duration of said corporation shall be perpetual.

Article III

This corporation is organized exclusively for charitable and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code

Article IV

The purpose of the corporation is exclusively charitable and educational for the support of a neighborhood community center and activities in the City of Alachua and the education of the public through programs, information, and presentations at and about that community center

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law) or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law)

Article V

The registered agent of the corporation is Constance M. Canney, 15319 NW 140th Street, Alachua, Florida 32615.

Article VI

All officers of the corporation shall serve without compensation. All directors of the corporation shall serve without compensation.

Article VII

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons. No part of the activities of the corporation shall be attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Article VIII

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future federal tax code), or shall be distributed to the Federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by the Circuit Court in Alachua County, Florida, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article IX

The number of directors constituting the initial board of directors shall be three. Election and replacement of directors in the future shall be as provided in the by-laws. Directors shall be unrelated to each other and officers and shall include one or more representatives of the community to be served.

Article X

The corporation shall have such members as stated in the by-laws.
