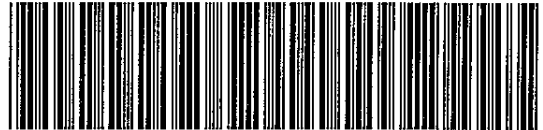




- Article I: The name of this not for profit corporation shall be known as the **SUN STATE QUARTET, Inc.**
