THE UNDERSIGNED, acting as the Incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of incorporation.

Article 1

The name of the corporation shall be:

Article 111

The purpose for which the cooperation is formed, and the business and objectives to be carried on and promotion by it, are as follows:

- 1. The purpose for which the cooperation is organized are to receive and maintain real or personal property, or both, and subject to the restrictions and limitations hereinafter set forth, to use and apply the whole or any part of the income therefrom and the principal thereof exclusively for charitable, religious, scientific, literary, or educational purposes either directly or by contributions to organizations that qualify as exempt organizations under section 501 © (3) of the Internal Revenue Code and regulations issued pursuant thereto as they now exist or as they may thereafter be amended.**
- 2. The specific purpose for which the cooperation is organized shall be:**

To establish and maintain a Church environment and to provide a place of worship for its members and the general public. To establish, maintain and conduct schools for religious instruction, and further other religious and charitable work.

3. To solicit funds and donations in kind and from time to time further the purposes of this cooperation.
4. No part of the net earnings of the corporation shall inure to the benefit of or be distributed to any Director or officer of the corporation or any member of the corporation or any other private individual (except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes), and no Director or officer of the corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets of the dissolution of the corporation.

Through majority vote, a two-third vote of the membership shall be required for the election of new Directors or removal of current Directors.


