**ARTICLES OF INCORPORATION
OF
FLORIDA BLACK EXPO, INC.
A Not-For-Profit Corporation**

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following articles of incorporation:

ARTICLE I - NAME

The name of the not-for-profit corporation is Florida Black Expo, Inc.

ARTICLE II - DURATION

The corporation shall have perpetual existence commencing on the date of filing.

ARTICLE III - PURPOSE

The corporation is organized and may engage in any activity, business or purpose not-for-pecuniary profit permitted under the laws of the United States and the State of Florida and not inconsistent with Chapter 617 Florida Statute. This corporation purpose includes but is not limited to event planning, fund raising, organizing and promoting conferences, seminars and training.

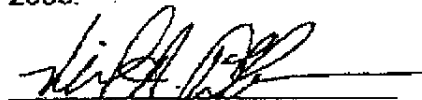
