ARTICLES OF INCORPORATION

We the undersigned, acting as incorporates of the Corporation pursuant to chapter 617, Florida Statutes, adopt the following Articles of Incorporation of such corporation under the following proposed Articles of Incorporation.

This organization will be incorporated as a church. This church is duly incorporated under the laws of the State of Florida under the corporate name of Spirit and Truth Worship Deliverance Centre, Incorporated and its principal place of business and mailing address shall be 20330 N. W. 32rd Avenue, Miami, Florida 33056.

ARTICLE II

This corporation is to have perpetual existence commencing upon the approval of the Secretary of State of this Article of Incorporation.

ARTICLE III - PURPOSE

Section 1 - Purpose: The general purpose or objective to be transacted is:

- a. to provide and maintain a church to proclaim the Gospel of Jesus Christ.
- b. to worship God Almighty,
- c. to minister the HOLY WORD,
- d. to promote the Christian spirit and to do all other acts in compliance with the teaching of our Lord and Savior, JESUS CHRIST, the Son of the Living God,
- e. to administer the ordinances of the Old and New Testament,
- to deepen the spiritual life among its members so that all members seek to attain the highest state in their Christian experience as true worshipers of God,
- g. to ordain Apostles, Prophets, Evangelists, Pastors, and Teachers, recognizing the five fold ministry as stated in the word of God, who are divinely called and qualified for the perfecting of the saints for the work of the ministry, and for the edifying of the Body of Christ (Ephesians 4:11-13).
- h. in addition ordaining Elders, Missionaries and Deacon(nesses) who will serve as leaders and officials among the people (Numbers 11:16) and who will hold the mystery of the faith in a pure conscience (1st Timothy 3:9).

Section2-Statement of Faith: This church accepts the Scripture as its authority in matters of faith and practice. Its understanding of Christian truth, as contained therein, is in essential accord with the beliefs of Spirit-filled churches, and its statement of creed is derived from the HOLY BIBLE.

ARTICLE IV - ORGANIZATION

The government of this church is vested in the Pastor and the body of believers who compose it. They control the admission, disciplining and removal of its members according to its own understanding of the Word of God and the church bylaws.

ARTICLE V - MEMBERSHIP

Section 1- Qualifications: Membership is open to all individuals who endeavor to be justified and made clean through faith and by the words of the Lord Jesus Christ. Members must adhere to the practices held by this church.

Section 2-Reception of Members: Admission of the above shall be by one of the following:

a. By Baptism:

1. Any person professing faith in the Lord Jesus Christ, giving evidence of a change of heart and the testimony of a Christian life may be received into this church upon baptism by immersion and upon a statement of endeavor to live a spirit-filled life.

- b. By Letter: Any person who has been released from another church and that church acknowledges that the applicant has been baptized, may be received upon receipt of a letter of recommendation from their respective church.
- c. By Christian Experience: Any believer, having been previously spirit-filled and baptized, may be received upon a satisfactory statement of Christian faith and experience.
 - Any person professing and exhibiting evidence of the Holy Spirit dwelling in his/her Christian life
 may be received into this church upon confirmation of the indwelling of the Holy Ghost as
 determined in the church's bylaws.

Section 3 - Duties of Members: Members are expected to be faithful in all spiritual duties essential to the Christian life, to attend consistently the services of this church, to give regularly to its support and benevolence, and to share in the promotion of its organized work for the body of Christ.

ARTICLE VI - Board of Directors

A Board of Directors will manage the affairs and activities of this Corporation. They may have powers to authorize the seal of the corporation. The number of directors that shall constitute the whole Board shall in no case be less than three (3). The Board of Directors shall be re-appointed by the Pastor and/or elected by the members at the annual meeting of the corporation to be held on such date as the Bylaws may provide, and shall hold office until their successors are appointed and/or elected.
