The following is placed at the beginning of article III: This corporation is founded exclusively for charitable religious purposes within the meaning of the IRS Code Sec 501(c)(3); namely: To establish and maintain a House of Chabad Chassidic Orthodox Jewish Worship and there to provide Jewish religious, educational, cultural, social and all other helpful services according to Torah-Halachic tradition based on the Code of Jewish Law (Shulchan Aruch) by Shneur Zalman of Liadi and other canonical texts of Orthodox Judaism. It will be empowered to pay salaries, as well as rent or buy personal or real property, in order to provide a place of worship as well as a parsonage for the Chabad Emissary and Rabbi Abraham Stolik and his family. Rabbi Stolik is the incorporator and he has been appointed by the Chabad Chassidic Movement according to Jewish Law. He is the spiritual head of the organization and the final authority in all matters pertaining to Ethics, Spirituality and Religious Law, including the sole authority to determine which questions or issues are are to be considered matters of Jewish Law and require his decision. This corporation shall not, except in an insubstantial way, engage in any activities or exercise any powers that are not in furtherance of its charitable religious purposes. It will not attempt to influence legislation, or or support political candidates in any way. No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to its directors, officers or any private person except that this corporation will be empowered to pay reasonable compensation for services rendered and make purchases of goods or services that are in furtherance of its exempt purposes. This corporation is empowered to supply all the foods, religious items and physical constructions/properties required according to Chabad Orthodox Jewish Law, including but not limited to, religious articles, kosher food, ritual immersion pools or transportation to any event or location which in the view of the Rabbi or directors is required for the fulfillment of the organization's mission of of the religious duties of any Jewish person. In the event of the dissolution of this corporation, the directors will, after clearing all debts, distribute any remaining assets to one or more charitable organizations recognized by the IRS under section 501(c)(3) that have similar exempt purposes.
