ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation for such corporation.

ARTICLE I.

The name of the corporation is: Lakeland Liberty, Inc.

ARTICLE II.

The period of duration of this corporation is perpetual, unless dissolved according to law. Corporate existence shall commence upon filing with the Secretary of State, State of Florida.

ARTICLE III.

The purpose or purposes for which the corporation is organized are: To assist young individuals in learning the game of basketball; to promote sportsmanship in athletics; and to promote the general welfare of the community through recreation and education.

ARTICLE IV.

The qualification for members and the manner of their admission are any adult individual who is related to a player associated with the organization or as otherwise provided for in the By-Laws.

ARTICLE V.

The street address and city of the initial registered office of the corporation is: 1210 Baker Drive, Lakeland, Florida 33810, (mailing address is P.O. Box 91926, Lakeland, Florida 33804-1926). The name of its initial registered agent is George T. Coward, whose street address is 1915 South Florida Avenue, Lakeland, Florida 33803.

ARTICLE VI.

The members of the corporation shall elect a Board of Directors from the membership. The number of Directors shall be set forth in the By-Laws and may be increased from time to time by the By-laws, but shall never be less than three (3)

members. The initial Board of Directors, who shall serve until the first annual meeting of the corporation or as otherwise provided for in the By-Laws are:

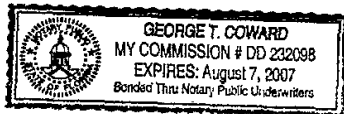
