

#### ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a non profit Corporation under Chapter 617 of the Florida Statutes.

#### **ARTICLE 1 - NAME**

The name of the Corporation is **CIRCLE OF LOVE OUTREACH CHURCH, INC.**, (hereinafter, "Corporation).

#### **ARTICLE 2 - PURPOSE OF CORPORATION**

#### ARTICLE 7 - TERM OF EXISTENCE

This Corporation shall have perpetual existence.

#### **ARTICLE 8 - CAPITAL STOCK**
