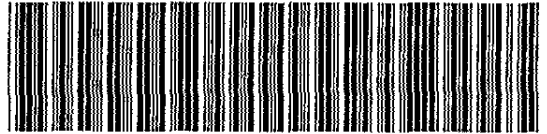

ARTICLE 14 - AMENDMENT


