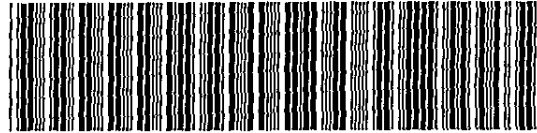

Article IV

No part of the net earnings of the Corporation shall inure to the benefit of any member, Trustee, director, officer or officer of the organization of any private individual (except that reasonable compensation may be paid for services rendered to or for the organization and no member, trustee, officer of the corporation organization or any private individual shall be entitled to share in the distribution of any of the organization assets.

Article V

New-01e
No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Article VI

In the event of dissolution, all of the remaining assets and properties of the organization shall after payment of necessary expenses then be distributed to such organizations shall qualify under section 501 C3 of the Internal Revenue Code of 1985 or corresponding provisions of any subsequent Federal or local government for a public purpose subject to the approval of the Justice of the Supreme Court of the State of Florida.

Article VII Members

The Corporation shall have voting members who shall be elected (and maybe removed) by the voting Members who shall have all the rights and privileges of Members of the Corporation. They by-laws may provide for non-voting members of one or more classes who shall be admitted in such manner and who shall have such rights privileges as are set forth in the by-laws, but who shall not have the right to vote. Directors are elected in accordance with by-laws.
