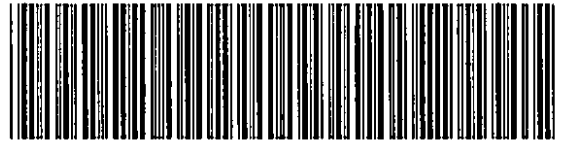


Article III is amended to adjust its Mission:
