**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
WISHBONE ANIMAL SHELTER, INC.**

Wishbone Animal Shelter, Inc., a Florida corporation not-for-profit (the "Corporation"), organized and existing under the laws of the State of Florida, hereby certifies as follows:

Pursuant to the unanimous written action of all of the Directors of the Corporation, in lieu of a special meeting, the following resolution was adopted on the 30<sup>th</sup> day of October 2003, amending the Articles of Incorporation:

RESOLVED, that Article 1 of the Articles of Incorporation filed with the Secretary of State of the State of Florida be amended as hereinafter set forth:

**1. Name**

The name of the Corporation is Wishbone Animal Rescue, Inc. The Corporation's principal office is located at 14130 Cedardale Street, Fort Myers, Florida 33905 in Lee County, Florida and its mailing address is P.O. Box 51097, Fort Myers, Florida 33994. The Board of Directors may from time to time move the principal office or mailing address of the Corporation to any other address in the State of Florida.

There are no members, or members entitled to vote on this Amendment.

WHEREUPON, at Fort Myers, Florida this 30<sup>th</sup> day of October 2003, the Corporation hereby certifies accordingly, under its corporate seal and the hand of its President and the adoption of this Amendment by the Board of Directors, so that, on the filing hereof, the Articles of Incorporation shall be deemed amended accordingly.
