

I have just recently learned that we have let our corporate status become inactive. The law firm that originally filed for us, and listed themselves as our registered agent using their address, did not forward the renewal form to us or advise us to renew. The attorney who had been helping us had left the firm. So I am enclosing the reinstatement form and the 2 years fees.

We are very strapped for cash and it would be a great hardship for us to pay penalty fees. There are no paid people at all on our all volunteer board and staff. We use all the monies collected to run the Events for the public high schools in Martin County, FL. We pay for the all night parties for the graduates immediately following graduation each of 3 nights. These parties, although seemingly for the graduates, are really to get them home safe to their parents, let them blow off their steam safely and protect the community. We have to work extremely hard to raise the funds needed and every dollar counts a lot. I am enclosing 2 checks, one for the payment associated with the regular fees and getting a Certificate of Status and the other for the nonprofit penalty. I am pleading with you to return the penalty check with the Certificate of Status and to reinstate our corporation. The reason I am sending it along is I can't afford any delays for we are doing things that require us to be an active corporation ASAP.
