

#### ARTICLES I Name

The Name of the corporation shall be: Front Porch, Ocala Inc.

## ARTICLE II Principal place of business and mailing address

## ARTICLE III Purposes

The specific purposes for which the corporation is organized are:

To provide capital resources for economic development; create opportunities for existing and new businesses; increase participation in existing educational programs and expand educational options. Foster health & safety and improve the quality of life in the community by developing partnerships with appropriate agencies. Develop relationship with housing and governmental agencies to provide safe, decency and affordable housing and provide an opportunity for residents to voice concerns and address issues concerning their community.

## ARTICLE X Distribution of Assets upon Dissolution

Upon the dissolution or other termination of the Corporation, no part of the property of the Corporation or any of the proceeds shall be distributed to or inured to the benefit of any of the members of the Corporation, but all such property and proceeds, subject to the discharge of valid obligations of the Corporation, shall be distributed as directed by members of the Corporation among one or more corporations, trusts, community chests, funds, or foundations organized and operated exclusively for religions, charitable, scientific, literary or educational purposes, no part of the net earnings of which inure to the benefit of any private shareholder, member, or individual, and no substantial part of whose activities consist of carrying on propaganda or otherwise attempting to influence legislation, or which does not participate or intervene in any political campaign on behalf of any candidate or public office, or other entities of the type which qualify for federal income tax exemption under Section 501 ©(3) of the Internal Revenue Code of 1986.
