Article III Purpose

Section 1. Grace Of God In Churches is organized exclusively for religious, charitable, and educational Purposes as defined by 501©(3) of the Internal revenue Code, as amended.

Section 2. With Signs/Wonder/Miracles following Act 4:29-30; One heart and Soul for the Deeds/Miracles to take place, before Jesus appeared with this Grace and Truth John 3:19.

Section 3. The specific purpose is to provide for and maintain the worship of Almighty God And Jesus Christ the only begotten of the Father, the administration of the sacraments and Other rites and ceremonies of the church, to spread the gospel of Jesus Christ through the Local church, churches of Affiliation, churches of Fellowship, evangelism, and missionary Endeavors. Section 4. G.O.G.I.C. shall also provide child day care services, a Bible College for ministerial licensing/Ordination and higher Christian education.

Section 5. Grace Of God In Churches shall voluntarily consist of association, affiliate churches and ministries of Apostolic Piety, especially of financial economics among the brethren. Acts 2:4, 38 / Acts 4:32-35. herein referred to as "the fellowship". And all authority is based Upon willing biblical submission and relationship. The fellowship shall endeavor among other benefits to provide accountability of ministry, ministerial relationship, church planting, Evangelism, training, organizational counsel and advice to association/affiliated churches And ministries. The fellowship does not seek to control its affiliate(s) and or associate member churches and ministries, nor desire legal holding on any property or assets of its members, with the exception of planted churches owned by the fellowship.

Section 6. Chartering of Independent churches/ministries seeking association, affiliate fellowship. Also use of the acronym G.O.G.I.C. name after church/ministry name of association. Affiliated churches/ministries who seek acronym name use for a Reputation Mark of the Highly Honored and Esteemed Individual Moral Apostle Teachings and Apostolic Power And Authority of whatever sort-domestic, social, political, economic, religious, intellectual Are to be used to bless, not exploit people, especially within the Body Of Christ of Righteous And Godly Piety with Justice Fairness Peace and Sacrificial Love that denies self of the gratifications of this current Generation to Display the much denied power of Grace and Truth to the powerless moral/mental Darkness we were in before Jesus Christ came of how we as Human beings dealt with one another in ungodly and unpius ways. This Fellowship will

Transcend the Darkness perpetrated against the GRACIOUSNESS AND TRUTH God sent Jesus Christ to Write in our Hearts Integrity, Character, Personality of his will for us who Will participate in this Divine work of Heart, In the Sphere the Holy Spirit will direct us to Effect.

Section 7. The Fellowship Constitutions and Fellowship Canons shall guide the Affiliates/ Associates churches and or ministries are herein referred to as the fellowship membership.

Section II. The President shall be the Chief Apostle and Bishop for life, and bylaws.

Section III. The Period of Duration of this corporation shall be Perpetual

Section IV. This Corporation shall be Independent-Non Denominational

Section V. Women Apostles/Bishop(s) are not allowed Biblically, Only Jurisdictionally as District Superintendents, Pastor, elder mothers, In-Nationally as Missionaries/Evangelist in their churches/ministries within fellowship.

After Initial Presiding President/Chief Apostle/Bishop office has ceased by bylaws terms any association, affiliate member man, Ordained, faithful to the fellowship growth may seek Election for Presiding President/Chief Apostle/Bishop. By the establishment of a General Board Of Elections Committee of (4), or more by bylaw amendment(s) to oversee elections Process for the fellowship and ensure Ethics in election for Blessed Theophany Consecration of the Heart of the Installlee.
