ARTICLES OF INCORPORATION

OF

A NON PROFIT CORPORATION

The undersigned, for the purpose of forming a Not for Profit corporation under the Florida Not For Profit Corporation Act, does hereby adopt the following Articles of Incorporation:

Article 1. Name.

The name of the Corporation is: Xender Art, Inc. The address of the principal office of this corporation and the mailing address will shall be 25 Osprey Avenue, Sarasota, Florida.

Article 2. Duration.

The duration of the Corporation is perpetual.

Article 3. Purpose.

The general purposes for which the Corporation is organized are the following:

A. To engage in and transact any lawful business, related to its charitable purpose as outlined in the bylaws, for which corporations may be incorporated under the Florida Not For Profit Corporation Act. No other purpose limits this general purpose in any way.

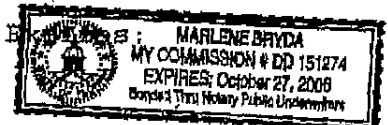
