### ARTICLE I

The name of the Corporation shall be: "One-body" Worldwide Ministries, Inc.

### ARTICLE II

The mailing address of this Corporation shall be: 7572 Sugar Bay Lane, Jacksonville, Florida 32256.

### ARTICLE III

This Corporation is organized exclusively for the religious purpose of media (television and radio) outreaches, overseas missions and humanitarian services.

### ARTICLE IV

The directors of "One-body" Worldwide Ministries, Inc. will serve as the Board of Trustees and shall be appointed by the President of the Ministry, who shall have the final authority on all matters governing the Ministry. Additional guidelines are as stated in the bylaws.
