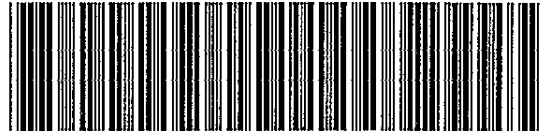

ARTICLES OF INCORPORATION  
OF

SECRETARY OF STATE  
TALLAHASSEE, FLORIDA

CHURCH OF CHRIST/FRENCH AND CREOLE CONGREGATION, INC.

We, the undersigned, hereby organize for the purposes of becoming a Corporation not for profit under Chapter 617 of the Florida Statutes, do ordain and establish these Articles of Incorporation.

ARTICLE I - NAME

The name of the Corporation is:

CHURCH OF CHRIST/FRENCH AND CREOLE CONGREGATION, INC.

ARTICLE II - DURATION

This Corporation will exist perpetually, commencing on the date of execution and acknowledgment of these Articles.

ARTICLE III - PURPOSE

The purposes for which the corporation is organized are to establish and maintain a place for the worship of Almighty God, our Heavenly Father; to support, propagate and encourage public worship and preaching and teaching of the Word of God and the Gospel of Jesus Christ; to provide for Christian fellowship for those of like faith; to assume our share of responsibility and the privilege of propagating the Gospel of Jesus Christ by all available means, both at home and in foreign lands; to provide assistance for the poor and needy and to do charitable work of any nature deemed beneficial.

ARTICLE IV - MEMBERSHIP

The initial members of the corporation shall consist of those persons who, on the date the existence of the corporation commences, are members in good standing of the CHURCH OF CHRIST/FRENCH AND CREOLE CONGREGATION, an unincorporated association, and such other persons as the members of the corporation shall from time to time elect.

## ARTICLE V - BYLAWS

The Bylaws of the corporation shall be adopted by the Board of Trustees and shall prescribe election of the Board of Trustees and Officers; the qualification for membership; the manner in which membership in the corporation may be terminated; the number of members of the corporation, present in person, necessary to constitute a quorum for the transaction of business at any annual, regular, or special meeting of the members of the corporation; and such other code or codes of rules necessary for regulation or management of the corporation.

## ARTICLE VI

### **Section 1**

Except as otherwise provided in these Articles of Incorporation, all corporate powers must be exercised by or under the authority of, and the affairs of the corporation managed under the direction of, the Board of Trustees. The method for the election of the Board of Trustees shall be stated in the Bylaws. The number of trustees shall be fixed by the Bylaws of the corporation, but shall not be less than three (3).

### **Section 2**

Except as limited by these Articles of Incorporation, the Bylaws, or any applicable provision of law, the Board of Trustees shall have all of the powers and duties of the Board of Directors of a Florida corporation not for profit.

### **Section 3**

The Board of Trustees initially shall consist of three (3) persons, and the names and address of the initial members of the Board of Trustees are as follows:

#### ARTICLE VII - OFFICERS

The officers of the corporation shall consist of a President, Vice President, Secretary and such additional officers as the Board of Trustees shall designate. The officers shall have such powers and duties as shall be prescribed by the Bylaws of the corporation or by resolution of the Board of Trustees not inconsistent with the Bylaws of the corporation or by resolution of the Board of Trustees not inconsistent with the Bylaws. ### **Section 2**

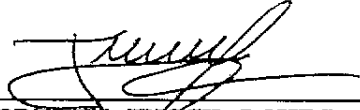
