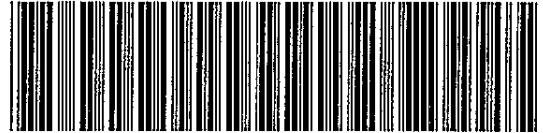



THESE articles of Incorporation are made pursuant to Chapter 617 Florida Statutes Not For Profit Corporation.

**ARTICLE ONE**

1. The name of the Corporation shall be TAMPA BAY BASEBALL COACHES ASSOCIATION, INC., a Florida Not For Profit Corporation.

**ARTICLE TWO**

2. The initial principal office of the Corporation shall be at 2127 W. Dr. Martin Luther King Jr. Boulevard., Tampa, Florida 33607.

**ARTICLE THREE**

3. The purpose of the Corporation is to recognize the accomplishments of high school baseball players and coaches in Hillsborough County, Florida and to recognize their outstanding efforts in the game of baseball.

**ARTICLE FOUR**

4. There shall be five (5) directors of the Corporation as follows:

**ARTICLE FIVE**

5. The Corporation powers shall be consistent with all powers authorized under Chapter 617 Florida Statutes and any other laws enacted in the State of Florida as to non-profit Corporations.

- a. Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- b. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of common Pleas of the count in which the principal office of the organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purpose

**ARTICLE SIX**


