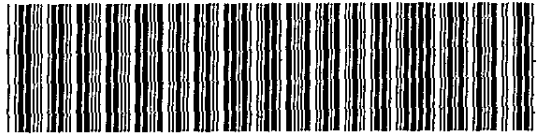

## **ARTICLES OF INCORPORATION**

In Compliance with Chapter 617, F.S., (Not for Profit)

### **Article I Name**

The name of the corporation shall be:

**SCARBOROUGH GROUP HOME INC.**

### **Article II Principal Office**

The principal place of business and mailing address of this corporation shall be:

4722 Cepeda Street, Orlando, Florida 32811

### **Article III Purpose**

The purpose for which the corporation is organized:

- A. The corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purpose of this corporation are:
  - Supervises and assists with evaluation of direct care staff.
  - Determines the training needs of consumers and assists with the development of an individualized program to overcome barriers to optimal functioning
  - Plans and implements preservice and in-service training for residential staff.
  - Implements support plans, IPP's, Short-term Objectives, and program plans. Completes graph, monthly progress notes, annual and semi-annual reports for compliance to minimum standards. Ensures that IPPs in the resident's best interest. Coordinate community inclusion activities.
- B. To excise all rights and powers conferred by the laws of the state of Florida upon nonprofit corporations.
- C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earring of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purpose.

**Article IV Manner of Election**

The manner in which the directors are elected or appointed:

The corporation shall have voting Members, who shall be elected (and may be removed) by voting members, and who shall have all the rights and privileges of members of the Corporation. Each voting member is entitled to one vote, voting for new members will be conducted on a quarterly bases. Removal of a member will be conducted on quarterly bases or can be held on a case by case bases.
