

Articles of Amendment to Articles of Incorporation of FREEDOM'S WAY MINISTRIES, INC.

Article III

The specific purpose for which this corporation is organized is:

To engage in charitable, religious, and educational purposes including making distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. AND FURTHER

- A. To provide a non-denominational ministry dedicated to advancing the Kingdom of God in obedience to the precepts of the Holy Bible and the teachings of the Lord Jesus Christ.
- B. To print, publish and distribute books and electronic media at no charge in connection to the purposes of this organization. To record, reproduce and distribute through CDs, DVDs, radio, television, literature and any other media the word of God to all people within reach, without respect to race, creed or nation of origin.
- C. To propagate the Word of God through personal appearances at seminars, or by invitation to other churches, for the purpose of educating individuals in the Word of God.
- D. To ordain ministers and Christian workers to the edification and unity of the Body of Christ.
 - E. To establish churches, auxiliaries, clubs and societies of a religious nature.
- F. To conduct Christian retreats, tours, seminars and camps to assist individuals and families in overcoming spiritual problems and grow in knowledge of God.
- G. To provide practical as well as spiritual assistance to the poor, homeless, ill or unemployed whenever possible.

Article IX

The corporation's existence shall be perpetual.

Article X

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, directors, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for the furtherance of the purposes set forth in the purposes clause (Article III) hereof.

Article XI

No substantial part of the activities of this organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision in this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code.

Article XII

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal revenue Code or corresponding section of any future federal tax code.
