ARTICLES OF INCORPORATION OF

ASSOCIATION OF IMMIGRANT FOR HAITIAN UNPROVIDED, INC. <u>Association des Immigrants pour les Demunis Haïtiens</u>

WE, the undersigned, here by associate ourselves for the purpose of becoming a non-profit corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida providing for the information, liability, rights, privileges and immunities of a corporation not for profit.

ARTICLE I Name of Corporation

The name of this corporation is Association of Immigrant for Haitian unprovided, Inc.

Purpose

The purpose of the corporation is to establish and maintain a regular Organization, cooperating with the missionary program of the Organization, and to provide Services and needs for the same in the City of Boynton, Palm Beach County, and State of Florida.

To establish, maintain and conduct schools for religious instruction, mission Organizations, mission stations, and to further other religious, educational and charitable work to that end, adopt and establish by-laws and make all rules and regulations deemed necessary and expedient for the management of its affairs in accordance with the law and not inconsistent with these Articles of Incorporation;

To acquire, buy, hold, own, sell, exchange, convey, lease, or otherwise dispose of goods, chattels, effects and merchandise;

To mortgage, lease, hypothecate, convey, exchange, and dispose of lands and chattels, to acquire, by gift, annuity, bequest, or otherwise, property, both real and personal or otherwise, and to promote the diffusion of religious literature and education loyal to the Services as held by this Organization; To do anything and everything pertinent to the above.

ARTICLE III

Qualification of Members

Persons who believe in repentance toward God, and faith in Jesus Christ as their Savior and Lord, and who are willing to confess Him publicly as Lord and follow Him in baptism and to observe the ordinances of Christ and to be governed by His laws and the Church, are qualified and eligible for membership in this mission corporation.

The manner of admission to membership shall be by acceptance by this Organization from other Organizations of like faith, being a part of this Organization and as herein before provided upon a favorable majority vote of the membership of said Organization corporation present at any meeting of the Organization.

ARTICLE IV

By-Laws

By-Laws of the corporation are to be made, offered, and rescinded by a majority of the qualified members of the organization, present and voting at a regular or special business meeting.

ARTICLE V

Corporate Existence

This corporation shall have perpetual existence unless sooner dissolved by law.

ARTICLE VI

Officers

The affairs of the corporation shall be managed by a President, Directors, Secretary and a Treasurer, as authorized by the Organization. Said officers shall be elected at the annual meeting of the Organization by a majority vote of the Organization. The President of the Organization shall serve until such time as he resigns, or is removed. The officers shall serve until such time as they resign or their successors are elected. These shall be:

Secretary Rev. Negro Prevalus

Treasurer Rev. Walker Delicat

ARTI ARTICLE VII

Number of Officers/Directors

ARTICLE IX

Amendment

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors at a meeting in which a quorum shall be present.

ARTICLE X

Principal Place of Business

The initial post office address of the principal office of this corporation is in the State of Florida; 655 Auburn Cir. E. Apt E, Delray Beach, Fl 33444. The Board of Directors may from time to time move the principal office to any other address in Florida and establish branch offices at any other place within or without the State of Florida.

ARTICLE XI

Dissolution

In event of dissolution, the residual assets of the Organization will be turned over to the Hope International Mission, which is a 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future Internal Revenue Code. The Organization must have an "organizing document" The Organization Constitution for Organizations is considered to be the "organizing document".

ARTICLE XII

Prohibited Activities

Notwithstanding any other provision of the these articles, this corporation shall not carry on any other activities not permitted to be carried on by (a) a corporation exempt from Federal Income Tax under Section 501 (c) (3) of the internal Revenue Code of 1954 or the corresponding provisions of any future United States Internal Revenue Law or (b) a corporation's contributions which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954 or any other corresponding provisions of any future United States Internal Revenue Law.

ARTICLE XIII Resident Agent

Pursuant to Chapter 48.091, Florida Statutes, the following is submitted in compliance with said act: Association of Immigrant for Haitian Unprovided, desiring to organize under the laws of the State of Florida, with its principal office as indicated at 655 Auburn Cir. E. Apt.E, Palm Beach County, State of Florida, has appointed Rev. Alberto F. Busby, as its agent to accept service of process within the State. Said agent's acceptance of this designation is indicated below, whose address is 706 SW 23 Ave., Boynton Beach, Fl 33435.




