

# FREEDOM IN CHRIST CHURCH, INC.

THE UNDERSIGNED, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Laws of Florida, do hereby certify:

# ARTICLE I: CORPORATE NAME

The name of the Corporation shall be FREEDOM IN CHRIST CHURCH, INC.

### ARTICLE II: PRINCIPLE PLACE OF BUSINESS

The principal office of this Corporation shall be located at 3942 Townsend Boulevard, Jacksonville, Florida 32277, but the meetings of the Board of Directors may be held at such places within or outside of the State of Florida, as may be designated from time to time.

#### ARTICLE III: CORPORATE PURPOSE

- Section 1. The corporate purpose is to bring the word of God, to the world, through the teachings of Jesus Christ as expressed in the Holy Bible. We will accomplish this by offering worship services, Bible study, and ministry. We especially wish to reach those who have been disenfranchised by traditional church organizations.
- Section 2. Freedom in Christ Church will operate as a not-for-profit corporation to further God's will as expressed in the Bible; feeding the hungry, clothing the naked, and restoring sight to the blind. We will further endeavor to encourage all people to seek the freedom that is only possible in Christ Jesus, freedom from addiction, freedom from abuse, and freedom from sinful behavior, which separate all persons from a relationship with God.
- Section 3. The Corporation shall be organized for charitable, religious, and educational purposes.

#### **ARTICLE IV: DURATION**

The duration of the Corporation shall be perpetual.
