ARTICLES OF INCORPORATION
OF
YOUTH CRIME WATCH OF BROWARD COUNTY, INC.
(A NOT FOR PROFIT CORPORATION)

The undersigned subscribers to the Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I – NAME

The name of the corporation is:

Youth Crime Watch of Broward County, Inc.

ARTICLE II – DURATION

This corporation shall exist perpetually.

ARTICLE III – PURPOSE

The general nature of the business to be transacted by the corporation is:

Any activity or business permitted under the laws of the United States of America and the State of Florida for the purpose of obtaining donations and grants in order to sustain our not for profit corporation.

ARTICLE IV – ELECTION OF DIRECTORS

At the first meeting of the new Board of Directors of the Organization, the board members shall vote for the President, President-Elect, Vice-President, Secretary and Treasurer.

ARTICLE V – INITIAL REGISTERED OFFICE AND AGENT

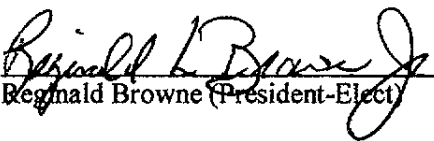
ARTICLE X – AMENDMENT

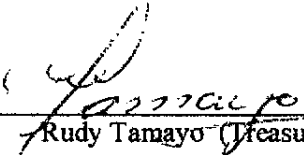
