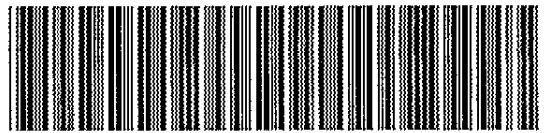

ARTICLES OF INCORPORATION  
OF

ARTICLE I NAME

The name of the corporation shall be SAINT AUGUSTINE VOLLEYBALL ASSOCIATION, INC

ARTICLE II PRINCIPAL OFFICE

The initial Directors of the corporation are Debbie Burkhardt, Mark Melton and Brian Pappas, all of Saint Johns County, Florida


ARTICLE VI INITIAL REGISTERED AGENT AND STREET ADDRESS
