ARTICLES OF INCORPORATION
OF
NEW BIRTH CHRISTIAN CHURCH, INC.

The undersigned incorporators of New Birth Christian Church, Inc., hereby associate themselves together as a Corporation not for profit as a benevolent association, under the following articles of Incorporation, to-wit:

ARTICLE I - NAME

The name of the Corporation not for profit shall be: NEW BIRTH CHRISTIAN CHURCH, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business & mailing address of this corporation shall be: P. O. BOX 614, FORT MYERS, FL 33902

ARTICLE III - PURPOSE

The general purpose of NEW BIRTH CHRISTIAN CHURCH, INC., hereinafter referred to as (the "Church"), shall be to establish and maintain a place of worship of Almighty God, to provide for Christian fellowship for those of like precious faith, to assume our share of responsibility and the privilege of propagating the Gospel of Jesus Christ by all available means, according to the religious beliefs and convictions as set forth in the Articles of Faith or spiritual guidance beliefs of said church.

ARTICLE IV - MANNER OF ELECTION

The manner of election shall be consistent with the Laws of the State of Florida: The Pastor of the Church shall be the President of the corporation. The affairs of this corporation shall be managed by a Board of Trustees composed of not less than five (5) members. The Trustees and Officers of the Church shall be elected by the member of the church at an annual meeting.

ARTICLES V - INITIAL OFFICERS/TRUSTEES

The Officers and Board of Trustees will manage the business of this corporation until the first election at the annual meeting of the members. The name and address of Officers and Trustees:

ARTICLES VI - BY LAWS

The By-Laws of this Corporation shall be made, altered, or rescinded by a majority votes of the members present at any regular or special meeting, due notice of which has been sent to all the members, in accordance with the By laws, or has been given and announced from the Alter of the Church on three (3) successive Sundays, and in like manner this Charter may be amended, altered or rescinded.

ARTICLES VII- PROPERTY

The Corporation shall have the power to acquire and hold title in fee simple, in trust, or otherwise, to both real and personal property, and to improve, sell, convey and dispose of all such property by a majority vote of the members of the corporation. No property belonging to the Corporation shall at any time be alienated or encumbered except by a majority vote of the members of the Corporation present and voting at a regular or special meeting duly called for that purpose. The highest amount of indebtedness or liability to which this corporation may at any time subject itself shall be \$100,000.00 or two-thirds (2/3) of the value of the property owned by it, whichever shall be the smaller.
