ARTICLES OF INCORPORATION In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be: The NCW Foundation, Inc.



ARTICLE II PRINCIPLE OFFICE

The principle place of business and mailing address of this corporation shall be: 5533 N. Military Trail, #1713, Boca Raton, FL 33496

ARTICLE III PURPOSE

The purpose of this corporation shall be to operate exclusively for charitable, scientific, literary and educational purposes and in furtherance of such goals, is authorized to do any or all activities which it is empowered to do under Chapter 617 F.S. as appropriate; provided, however, that nothing herein shall be construed as allowing any activities which would jeopardize the corporations tax-exempt status or otherwise be inconsistent with its classification as an organization described in section 501(c)(3) of the Internal Revenue Code of 1954 or corresponding provision of any future United States Internal Revenue Code.

The general purpose of the corporation shall be to better the welfare of children in need, including but not limited to aid to disadvantaged and/or disabled children and supporting childhood decease prevention and/or cure.

ARTICLE IV MANNER OF ELECTION

Directors of the corporation shall be elected or appointed as set forth in the Bylaws of the corporation.

ARTICLE V INITIAL DIRECTORS AND/OR OFFICERS

After incorporation, the incorporators shall hold an organizational meeting to elect directors and complete the organization of the corporation per 617.0205. Three initial directors shall be elected.

ARTICLE VIII PROHIBITED ACTIVITIES

No part of the net earnings of the corporation shall inure the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the organization shall be carrying on propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Not withstanding any other provision of these articles, the corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal Income Tax under Section 601 (c)(3) of the Internal Revenue Code of 1954.

ARTICLE IX DISTRIBUTION UPON DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code, or shall be distributed to federal government, or to a state or local government, for exclusive public purposes. Any such not so disposed shall be disposed by a court of competent jurisdiction in the county in which the principle office of the corporation is located, exclusively for such purposes

or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
