FIRST ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

CHRISTIAN CHURCH OF WINTER SPRINGS, INC. (A Florida Not For Profit Corporation)

Pursuant to Sections 617.1002 and 617.1006, Florida Statutes, CHRISTIAN CHURCH OF WINTER SPRINGS, INC., a Florida not for profit corporation (the "Corporation"), hereby adopts the following First Articles of Amendment:

FIRST:

The Articles of Incorporation of the Corporation were filed on November 12,

2003, and assigned document number N03000009846.

SECOND:

Article I of said Articles of Incorporation is hereby amended in its entirety to change the name of the Corporation by deleting the provision of said Article I as

the same now exists and by substituting in lieu thereof, the following:

"ARTICLE I

NAME OF CORPORATION

The name of the corporation is NEW COVENANT ANGLICAN CHURCH, INC. "

THIRD:

All other provisions of the Articles of Incorporation remain unchanged and in full

force and effect.

FOURTH:

The foregoing amendment, as recommended for adoption by the Vestry of the Corporation, was adopted by a majority vote of those Members present at a duly noticed special meeting of the Members of the Corporation at which a quorum was present on the life day of October, 2009.
