ARTICLE VI - BOARD OF DIRECTORS, of the Articles of Incorporation, shall be amended by deleting the entire ARTICLE VI and replacing same with the following:

#### ARTICLE VI - BOARD OF DIRECTORS

The affairs of this Association shall be managed by a Board of Directors which shall consist of not less than three (3) nor more than nine (9) Directors. Directors shall be members of the Association. Directors shall be elected at the annual meeting and shall serve for a period of two (2) years (after initial one year terms for a minority of the Board to implement a staggered term system) and until their successors have been duly elected and qualified.
