

**ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a nonprofit corporation under the Florida Business Corporation Act, hereby adopt the following articles of incorporation:

ARTICLE ONE - NAME

The name of the corporation is Heaven-Bound Ministries, Inc.

ARTICLE TWO - PURPOSE

This ministries believing the Bible to be the inspired Word of God, and the only divinely authorized rule of faith and practice, and acknowledging its adherence to all teachings of Jesus Christ, declare and incorporate for the following purposes:

1. Evangelism Missions to proclaim the Gospel of Jesus Christ to the lost and to promote the cause of world evangelism and missions.
2. Teaching Discipleship to preach and teach the Word of God for the edification, instruction and disciple of believers, and to promote Christian education.
3. Benevolence to minister to the suffering and needy.
4. Worship/Fellowship to maintain regular services for both devotional and public worship, and to promote the spiritual welfare of all ministry families through Christian education and personal spiritual development.

The corporation is organized exclusively for charitable, religious and educational purposes as will qualify it as a tax-exempt organization under the Internal Revenue Code.

ARTICLE THREE - DURATION

The term of existence of the corporation is perpetual.

ARTICLE FOUR - PRINCIPAL OFFICE OF CORPORATION

ARTICLE FIVE - DIRECTORS


