**Article of Incorporation

The undersigned incorporators for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I- Name of the corporation

The name of the corporation shall be:

Article II- Nature or purpose of the Business

The purpose of the Corporation is to engage in any lawful activity permitted by the law of Florida. **The primary function of the Corporation is to: "reach out to the impoverished children in the Island of Haiti, to built an Orphanage and to provide Christian educational and Spiritual services for those children.** The corporation has established goals and objectives, which coincide with its purpose (see bylaws) This corporation shall function as a non- profit corporation in accordance with Florida statutes, and shall operate under the auspices of the 501 (c) (3) tax exempt section of the internal revenue code of 1986.

Article IV- Prohibitions of the corporation

No part of the net earning of the corporation shall inure to the benefit of, or be distributable to its members, trustees, offices. Or other private persons, excepts that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the preceding articles hereof. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501 (c) (3) of the internal revenue service law.

Article V- Dissolution of the Corporation

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning section of 501 (c) (3) of the internal revenue service code, or the corresponding section of any future federal tax code, or shall distributed to the Federal Government or to a State or local government for public purpose. Any such assets not so disposed of, shall be disposed by court of competent jurisdiction of the county in which the principle office of the corporation is then located, exclusively for such purposes or to such organization of organizations, as said court will determine, which are organized and operated exclusively for such purposes.




CERTIFICATE DESIGNATING REGISTERED AGENT
