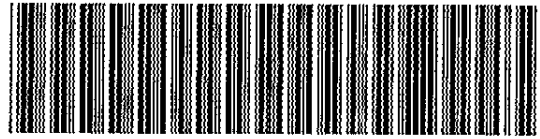

The name and Florida street address of the registered agent is: Jonathan Rucker, 2611 N. Riverside Drive, #803, Pompano Beach, Florida 33062.


