

### HIALEAH-MIAMI SPRINGS ROTARY CLUB INC., . A Not-For-Profit Corporation

SUSCRIBER, UNDERSIGNED to this Articles Incorporation not-for-profit pursuant to F.S. § 617, adopts the following Articles of Incorporation:

### ARTICLE I

The name of this corporation shall be HIALEAH-MIAMI SPRINGS ROTARY CLUB INC., a not-for-profit Corporation.

### ARTICLE II

The address of the principal office and the mailing address of the not-for-profit Corporation is:

### ARTICLE III

The purpose of this no-for profit corporation is:

- To provide an entity to which the individual Rotary Club as a member of Rotary International encourages and fosters the ideal of service as a basis for a Rotary enterprises.
- Said corporation/organization is organized exclusively. for charitable, purposes, including for such purposes, the making of distributions to organizations under section 501(c)(3) of the Internal Revenue Code (or the corresponding section of any future Federal tax code).
- (c) No part OÍ. the net earnings οĬ corporation/organization shall inure to the benefit of, or be distributed to its members, trustees, directors, officers or other private persons, except that the corporation/organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments distribution in furtherance of section 501(c)(3) purposes. No substantial part of the activities of the corporation/organization shall be the carrying on of

propaganda, or otherwise attempting to influence legislation, and the corporation/organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation/organization shall not carry on any other activities not to carried on (a) by a corporation/organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code) or (b) by a corporation/organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code (or corresponding section of any future Federal tax code).

(d) Upon dissolution of this corporation/organization assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government or to a state or local government for a public purpose.

### ARTICLE IV

The directors of this Not-For-Profit Corporation shall be elected annually as directed by the by-laws.
