THE REASONING AND DESIRE TO CREATE THIS ORGANIZATION ARISE FROM MY INVOLVEMENT OVER A PERIOD OF MORE THAN TWELLEVE YEARS WITH LOW AND NO-INCOME MEN, WOMEN, CHILDREN, AND FAMILIES IN THE FLORIDA CITY AND HOMESTEAD AREA. MOST OF THESE MEN AND WOMEN ARE MIGRANT WORKERS WHO HAVE LITTLE OR NO FOOD, CLOTHING OR HEALTH INSURANCE THESE FAMILIES ARE IN A DIRE NEED OF ASSISTANCE, WHICH I HAVE ATTEMPTED TO PROVIDE OVER THE PAST DECADE, BUT LIKE TO DO MORE. CREATING A NON-PROFIT ORGANIZATION WOULD GIVE ME ADDITIONAL LEVERAGE AND CREDIBILITY WITH THE POTENTIAL DONORS, AND LEND ADDITIONAL 'LEGITIMACY' TO MY EFFORTS.
