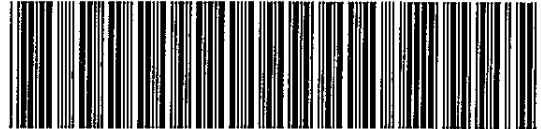

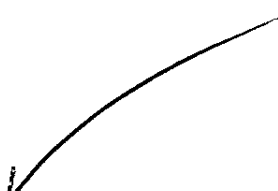

ARTICLES OF INCORPORATION
of
FAMILIES FOR VOTER EMPOWERMENT ASSOCIATION Inc.
A NONPROFIT CORPORATION

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the **State of Florida**, do hereby certify:

Article 1:

The name of the corporation shall be: **Families For Voter Empowerment, Association Inc.**

Article 2:

The place in this state where the principal office of the Corporation is initially located in the City of **Jacksonville, Duval County**.

Article 3:

Said corporation is organized exclusively for **Charitable, Educational and Civic Purposes**, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (4) of the Internal Revenue Code, or the corresponding section of any future tax code. The specific purpose of the corporation is to; Educate the common American family on its civic responsibility to participate in the electoral process; To register entire families consisting of eligible voters; To unite and organize the family voter into a viable voter's block, in an effort, to effectuate positive responses from elected representatives on matters that most affect the quality of life of the American family.

Article 4:

Article 5:

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in **Article 3** hereof. Notwithstanding any other provisions of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of the corporation.

Article 6:

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (4) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government or to state or local government for a public purpose. Any such assets not so disposed shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said court shall determine, which operated exclusively for such purposes.
