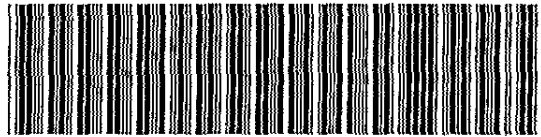

Pursuant to Chapter 617.0202, Florida State articles of incorporation set forth the following:
