Amendments to Articles of Incorporation

Article VIII

This organization is organized exclusively for educational and charitable purposes within the meaning of section 501 (c) (3) of Internal Revenue Code.

Article VIX

Notwithstanding any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal Income Tax under section 501 (c) (3) of Internal Revenue Code of 1954 or the corresponding (provisions of any future United States Internal Revenue Law) or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code of 1964 (or the corresponding provision of any future United State Internal Revenue Law).

Article X

Upon the winding up and dissolution of this organization, after paying or adequately providing for the debts and the obligations of the organization, the remaining assets shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for educational and charitable purposes and which has established its tax exempt status under section 501 (c) (3) of the Internal Revenue Code.
