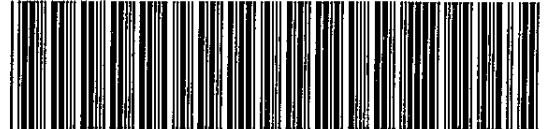

We, the undersigned, with other persons being desirous of forming a corporation for charitable and philanthropic purposes, under the provision of the Florida Statutes, do agree the following;

ARTICLE I

The name of this corporation is ALL GOD CHILDREN COMMUNITY CHURCH, INC.

ARTICLE II

The general nature of the objects and purposes of this corporation shall be to establish a church to do and conduct all business that is necessary regarding the establishment and maintenance of said church.
