The undersigned natural person, for the purpose of forming a not-for-profit corporation under Chapter 617 of the Florida Statutes, does hereby adopt the following Articles of Incorporation.

**ARTICLE I**

**Name and Principal Office**

The name of the corporation is St. Augustine/St. Johns County Health Ministry Vision Group, Inc., and the principal office is located at 8050 U.S. Highway A1A South, Suite 404, St. Augustine, Florida 32080.

**ARTICLE II**

**Purpose**

The Corporation is organized for any lawful purpose or purposes authorized by the not-for-profit corporation laws of the State of Florida including without limitation promoting health improvement and building health ministry capacity through integrating the faith and health communities, developing coordinated faith and health networks, improving access to health care and medical care, improving the quality of personal, family and community health, and improving the quality of health education, while focusing on the whole human being concept, wholistic health, and whole-person care.

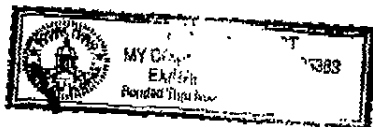
