ARTICLES OF INCORPORATION OF UNITED FELLOWSHIP INC.

ARTICLE 1: NAME

The name of the fellowship shall be UNITED FELLOWSHIP INC.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this fellowship shall be:

ARTICLE III: PURPOSE

UNITED FELLOWSHIP INC. shall be a non-profit fellowship and is organized exclusively for charitable, religious, educational and scientific purposes under section 501(c)(3) of the Internal Revenue Code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
