

ARTICLES OF INCORPORATION
OF
MID-FLORIDA QUARTER MIDGET RACERS' ASSOCIATION, INC.

A Florida corporation not for profit.

ARTICLE I. - NAME

The name of this Corporation shall be MID-FLORIDA QUARTER MIDGET RACERS' ASSOCIATION, INC.

ARTICLE II. - DURATION

The duration of this Corporation is perpetual. The date and time of commencement of the corporation existence is the time of filing of the Articles of Incorporation by the Department of State of the State of Florida.

ARTICLE III. - PURPOSE

The purpose of this Corporation shall be exclusively charitable in nature, to-wit: To engage exclusively in activities for charitable and educational purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future federal tax code). Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or sections of any prior or future Internal Revenue Code, or to the Federal State or local government for exclusive public purpose.

ARTICLE IV. - PRINCIPAL OFFICE AND REGISTERED AGENT

The street address of the principal office of the Corporation is 531 Dog Track Road, Longwood, Florida 32750. The mailing address of the principal office of the Corporation is Post Office Box 924, Clarcona, Florida 32710-0924. The name and address of the initial registered agent of the Corporation is Richard S. Taylor, Jr., 531 Dog Track Road, Longwood, Florida 32750.

ARTICLE V. - MEMBERSHIP

The members shall be those families and individuals who join on an annual basis for the purpose of participating in quarter midget racing.

The Directors may be changed from time to time by the by-laws but shall never be less than three (3). Election or appointment of the Directors shall be as prescribed in the by-laws.



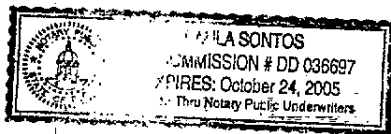


