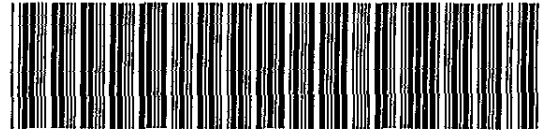

ONE:




