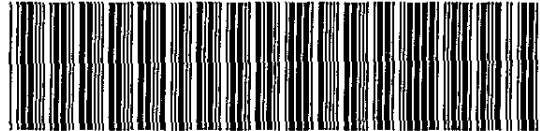

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617 of the Florida Statutes, adopts the following Articles of Incorporation:

Article I

Name

The name of the corporation shall be:

JDS Productions, Inc

Article II

Principal Place of Business and Mailing Address

The principal place of business and the mailing address of this corporation shall be: 1007 N. Himes Avenue, Tampa, FL., 33607

Article III

Purpose

The principal purpose for which the corporation is organized is to foster, encourage, and develop popular public appreciation and enjoyment of all musical, and dancing productions; to provide means, equipment, and facilities to afford qualified persons an opportunity to acquire knowledge and enjoyment of the science of stagecraft and practical experience in musical and dance productions; to own, lease, operate, and maintain one or more workshops and theaters; to cultivate, promote, foster, sponsor, and develop the understanding, taste, and love of the musical arts; and to do all and everything necessary, suitable, and proper for the attainment of any of the purposes, the accomplishment of any of the objects, or the furtherance of any of the powers hereinabove set forth.

Article IV

Manner of Election of Directors

The manner in which the directors are elected or appointed is as follows:

At the annual meeting, the members shall elect from among the members of the corporation, one (1) director for a term of one year.

Article V
Directors

The number of persons constituting the first board of directors is one (1). The name and address of the first director who is to serve until the successor is elected and qualified is:


