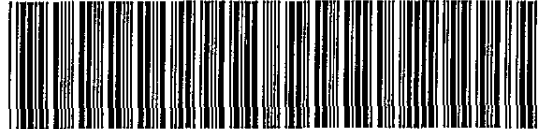

Articles of Amendment to Articles of Incorporation

Central Florida Yellow Jackets, Inc.

AMENDMENTS ADOPTED

Article VIII

The purpose is also exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501 (c) 3 of the Internal Revenue Code of 1986 or corresponding provision of any future United States Internal Revenue Code.

Article IX

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried n by an organization exempt from Federal income tax under section 501 (c) 3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Revenue Law.
